HEALTH GUARANTEE

1. The puppy is guaranteed to be in good health, to the best of seller's knowledge, at the time of sale.
2. The puppy has been vaccinated for Distemper, Parainfluenza, Adenovirus (both types), and Parvo. The puppy has been routinely wormed with Strongid-T. He/She will need booster shots every 2-3 weeks until it has had a total of 3 which should be completed by 16 weeks of age.
3. The puppy has a health guarantee extending to three (3) days beyond the day the buyer takes possession of the puppy.
4. The puppy must be checked by a veterinarian within three (3) days for the guarantee to be valid. If the veterinarian finds the puppy to be physically unsound, it can be exchanged for another puppy of equal value of the customer's choice, (immediately or as soon as one becomes available), provided a letter from the examining veterinarian is offered as evidence of the puppy's problem. Notification of such must be made to the seller within this three (3) day period for guarantee to be honored. Common ailments such as hypoglycemia, coccidia, umbilical hernia's and other minor viral illnesses are not cause for exchange of a puppy.
5. In the case of the puppy's demise within the three (3) day period (or one (1) year), an autopsy must be arranged and paid for by the Buyer, and findings must be submitted to the Seller before any replacement will be made.
6. Guarantee extends up to, and no more than, one (1) year from statement date against major genetic defects; i.e., epilepsy, deafness, blindness, liver shunt, or a life-threatening heart murmur.
7. The seller assumes no responsibility for any medical expense, death, allergies, training difficulties, behavioral problems, or any other reason, once the buyer assumes ownership. ***Seller will not be liable for any expense incurred by the Buyer.***
8. Seller does not guarantee the breeding capability of the puppy; he/she is pet quality only. However, ***registration is not limited.***
9. Seller does not guarantee the size of the puppy fully grown. Sizes and confirmation are an estimated guess due to the size of the lineage and the same goes for the color and markings as some may get darker, lighter, or lose a marking.
10. Dew claws and Tail docking are done when the puppy is 3-5 days old. Seller does not crop the ears. If the buyer chooses to crop the ears, any and all medical expenses associated with that are at buyer's expense.
